MEADOW PINES COMMUNITY DEVELOPMENT DISTRICT REGULAR BOARD MEETING JUNE 20, 2019

A. CALL TO ORDER

District Manager Armando Silva called the June 20, 2019, Regular Board Meeting of the Meadow Pines Community Development District (the "District") to order at 9:37 a.m. in the Cobblestone Clubhouse located at 14701 SW 10th Street, Pembroke Pines, Florida 33027.

B. PROOF OF PUBLICATION

Proof of publication was presented which showed that notice of the Regular Board Meeting had been published in the *Broward Daily Business Review* on October 11, 2018, as legally required.

C. ESTABLISH A QUORUM

Mr. Silva determined that the attendance of Chairman Douglas Harrison, Vice Chairman Leon Brown and Supervisor Jennifer Marmanillo constituted a quorum and it was in order to proceed with the meeting.

Staff in attendance were: District Managers Armando Silva and Nancy Nguyen of Special District Services, Inc.; and General Counsel Vanessa Steinerts of Billing, Cochran, Lyles, Mauro & Ramsey, P.A.

Also in attendance was Maria Hernandez, the Cobblestone Community Property Manager.

D. CONSIDER APPOINTMENTS TO FILLL VACANCIES: SEATS #1, #3 & #5

Mr. Silva reminded the Board that Douglas Harrison and Leon Brown had not qualified for re-election to Seat #1 and Seat #3, respectively, nor did any other qualified elector qualify for election to same. At the October 18, 2018, Board meeting vacancies were declared, effective as of 11/20/2018 in Seats #1, #3 and #5; and the incumbents, Mr. Harrison and Mr. Brown, would serve as Holdover Board Members for no more than ninety (90) days or until the declared vacancies had been filled.

Mr. Harrison and Mr. Brown, both serving as Holdover Board Members and also in attendance, expressed their interest in continuing to serve as Board Members. A discussion ensued after which;

A **motion** was made by Mr. Harrison, seconded by Mr. Brown and unanimously passed to *appoint* Douglas Harrison and Leon Brown, qualified electors, to the unexpired 4-year terms of office in Seats #1 and #3 and such terms of office will expire in November 2022.

Mr. Silva noted that there was still a vacancy in Seat #5. Mr. Silva requested that the Board direct any interested and qualified persons to contact him regarding serving on the Board of the District.

E. ADMINISTER OATH OF OFFICE & REVIEW BOARD MEMBER RESPONSIBILITIES AND DUTIES

Mr. Silva, Notary Public in the State of Florida, administered the Oath of Office to Mr. Harrison and Mr. Brown, who had been appointed to Seats #1 and #3, respectively. Mr. Silva reminded Mr. Harrison and Mr. Brown of their duties and responsibilities as a returning/appointed Board Members with emphasis on the Sunshine Law, Financial Disclosure for Public Officials (2018 Form 1 must be completed and mailed to the Supervisor of Elections in the County of residency within thirty {30} days of appointment) and the Code of Ethics for Public Officials.

Note 1: Mr. Harrison stated that neither he nor Mr. Brown had received a stipend of \$200 per District meeting.

F. ELECTION OF OFFICERS

As a result of the changes to the Board of Supervisors, Mr. Silva recommended that re-election of the District's Officers take place. He provided the following slate of names for election:

- Chairperson Douglas Harrison
- Vice Chairperson Leon Brown
- Secretary/Treasurer Armando Silva
- Assistant Secretaries Jennifer Marmanillo and Nancy Nguyen

A discussion ensued after which;

A **motion** was made by Mr. Harrison, seconded by Mr. Brown and unanimously passed to elect the Officers as listed and stated above.

G. ADDITIONS OR DELETIONS TO THE AGENDA

There were no additions or deletions to the agenda.

H. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

I. APPROVAL OF MINUTES 1. October 18, 2018, Regular Board Meeting

Mr. Silva presented the minutes of the October 18, 2018, Regular Board Meeting and asked if there were any corrections and/or revisions. There being none, a **motion** was made by Mr. Harrison, seconded by Mr. Brown and passed unanimously approving the minutes of the October 18, 2018, Regular Board Meeting, as presented.

J. OLD BUSINESS

Mr. Silva updated the Board on the damages to the wooden guardrail near the wetland mitigation area located east of 14715 SW 15th Court, which were caused by the resident who resides at 875 SW 147th

Terrace. He advised that the wooden guardrail had been repaired and he would follow up with Geico on the status of the insurance claim.

K. NEW BUSINESS

1. Consider Resolution No. 2019-01 – Adopting a Fiscal Year 2018/2019 Proposed Budget

Mr. Silva presented Resolution No. 2019-01, entitled:

RESOLUTION NO. 2019-01

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE MEADOW PINES COMMUNITY DEVELOPMENT DISTRICT APPROVING A PROPOSED BUDGET AND NON-AD VALOREM SPECIAL ASSESSMENTS FOR FISCAL YEAR 2019/2020; AND PROVIDING AN EFFECTIVE DATE.

Mr. Silva read the title of the resolution into the record and indicated that the proposed 2019/2020 fiscal year budget had been balanced by designating a carryover of approximately \$12,500 from the projected fund balance as of September 30, 2019. Mr. Silva advised that since the overall proposed assessments were not increasing in the fiscal year 2019/2020, letters to residents would not be required. Furthermore, he stated as part of Resolution No. 2019-01, the Board must set a date for the public hearing to adopt the fiscal year 2019/2020 final budget and assessments. Additional discussion took place on the proposed budget after which;

A **motion** was made by Mr. Harrison, seconded by Ms. Marmanillo and unanimously passed approving and adopting Resolution No. 2019-01, *as presented*, setting the public hearing to adopt the fiscal year 2019/2020 final budget and assessments for August 22, 2019, at 9:30 a.m. in the Cobblestone Clubhouse Meeting Room located at 14701 SW 10th Street, Pembroke Pines, Florida 33027; and further authorizing publication/notice of the budget public hearing, as required by law.

Note 2: Mr. Harrison stepped out of the meeting room at approximately 9:53 a.m. and returned at approximately 9:55 a.m., during which time no items were discussed.
